5.2 Finance Committee

Finance Chair Irene Odell reported on the highlights of the Finance Committee meeting on January 16, 2023 which included:

• As of Nov 30, 2023, HHHS is in a \$2.4M deficit position

- Deficit consists mostly of purchased services healthcare human resources, Emergency Department physician staffing and administrative positions
- Board is in full support of HHHS leadership as various mitigating strategies had been implemented

6.0 REPORT OF PRESIDENT AND CEO

6.1 CEO's Report to the Board

Referring to her written report that had been pre-circulated with the agenda, President and CEO Carolyn Plummer apprised the Board of the following items:

- Health Human Resources Update
 - ongoing health human resource shortages continue to affect HHHS with agency staffing heavily relied upon to keep the Emergency Departments open
 - trying very hard to recruit and improve the work environment at HHHS to retain its valued employees
 - Restarting CEO Coffee Talk (paused during pandemic) to engage with employees
- COVID-19 Update
 - o Outbreaks declared over at Hyland Crest and Acute Care
 - CEO Plummer expressed her gratitude for the hard work of the staff, IPAC team and management staff in dealing with the outbreak
 - New variant of COVID-19 in the community and precautionary protocols would continue at HHHS
- Government Updates
 - o New policy introduced to allow community clinics to address surgical wait times
 - o This new policy invoked concern regarding HHR implications
- HHHS Updates
 - Strategic planning would be completed in the very near future; CEO Plummer thanked the community, staff and stakeholders for participating in the surveys and/or meetings.
 - The CT scanner application is almost complete and will be submitted in next few weeks; CEO Plummer thanked the community for the overwhelming number of letters of support
 - HHHS is preparing for Accreditation in December of this year

- Community Program Updates
 - CEO Plummer highlighted the community program 'Emergency Response System" which has seen an increase in the number of subscribers recently; this easy-to-use system ensures seniors who live alone or adults who live with disabilities and/or illnesses can receive quick assistance whenever needed; to call for help, clients can simply press a button on a device they wear (a pendant or wristband)
- Long-Term Care Updates
 - Staffing changes in Long-Term Care: Tina Amodeo has accepted the position of Assistant Director of Care in Hyland Crest and Tracy Salvatori has accepted the position of Assistant Director of Care in Highland Wood
 - Thank you and well wishes to Dr. Tina Stephenson as she retires as Medical Director of Highland Wood after 22 years of dedicated service; Dr. Mike Armstrong would become Interim Medical Director until permanent replacement is recruited
 - Flooring replacement is continuing in both Long-Term Care Homes, 7 rooms per home

9.0 FOUNDATION AND AUXILIARY

9.1 Foundation

Melanie Klodt Wong, Executive Director of the Haliburton Highlands Health Services Foundation (HHHSF), updated the Board on fundraising, having just completed the biggest campaign of the year "Believe in The Magic of Giving". It was reported that 12% more than last year had been donated by 715 generous donors with 60% of donations coming from outside of the County. It was reported that several large gifts from grateful patients had been received with the request that the funds be designated for Diagnostic Imaging. On behalf of Eric Recalla, Chair of the Haliburton Highlands Health Services Foundation, Executive Director Klodt Wong extended publically their support of the HHHS application for a CT scanner and committed their fundraising efforts to this project.

9.2 Minden Health Care Auxiliary (MHCA)

With the President of the Minden Health Care Auxiliary, Gail Simon, being unable to attend the meeting, Auxiliary Secretary, Pat Bradley reported in her absence. It was reported that the Minden Health Care Auxiliary had raised \$35,000 last year which was put towards capital items. It was further reported that the next meeting of the MHCA is Tuesday, Feb. 7th with fundraising initiatives for this year being on the agenda.

10.0 PUBLIC QUESTION PERIOD

Lisa Gervais from *The Highlander* inquired if the province has caught up with its funding owed to HHHS. CFO Darlene Moore reported that the funds had been received.

Lisa Gervais from *The Highlander* inquired as to the total funds raised by the Believe in the Magic of Giving Campaign. Executive Director of the HHHSF, Melanie Klodt Wong reported that \$274,000 had been generously donated.
